International Regulations

IOSCO (International Organization of Securities Commissions)

- ★ Created a task force in light of investigations regarding attempted manipulation of major interest rate benchmarks
 - January 2013: issue of first Consultation Report open to comments from regulatory and industry fora
 - July 2013: issue of Final Report “Principles for Financial Benchmarks”

ESMA (European Securities and Market Authority)

- ★ June 2013: issue of “ESMA-EBA Principles for Benchmark Setting Processes in the EU”

At this stage: no regulation, only principles determining a new frame to operate

amLeague as Index Administrator

- ★ amLeague produces **Investable Indices** in compliance with the 2 international set of principles. Those principles cover all stages of the Benchmark process :

1. Benchmark Data Submission
2. Benchmark Calculation
3. Benchmark Administration
4. Benchmark Publication
5. Continuity of Benchmarks

A new class of indices

- ★ amLeague INDEXING Factory provides investors with a smart way to invest in an Index based on asset management (instead of market indices)
- ★ Indices can either be amLeague labelled Indices (such as amLeague-Low Beta Europe[©]) or customised Indices
- ★ Several criteria can be used to create the index : performance, alpha produced by the best active asset managers, lowest beta, IR, Sharpe ratios, value, Growth, etc.

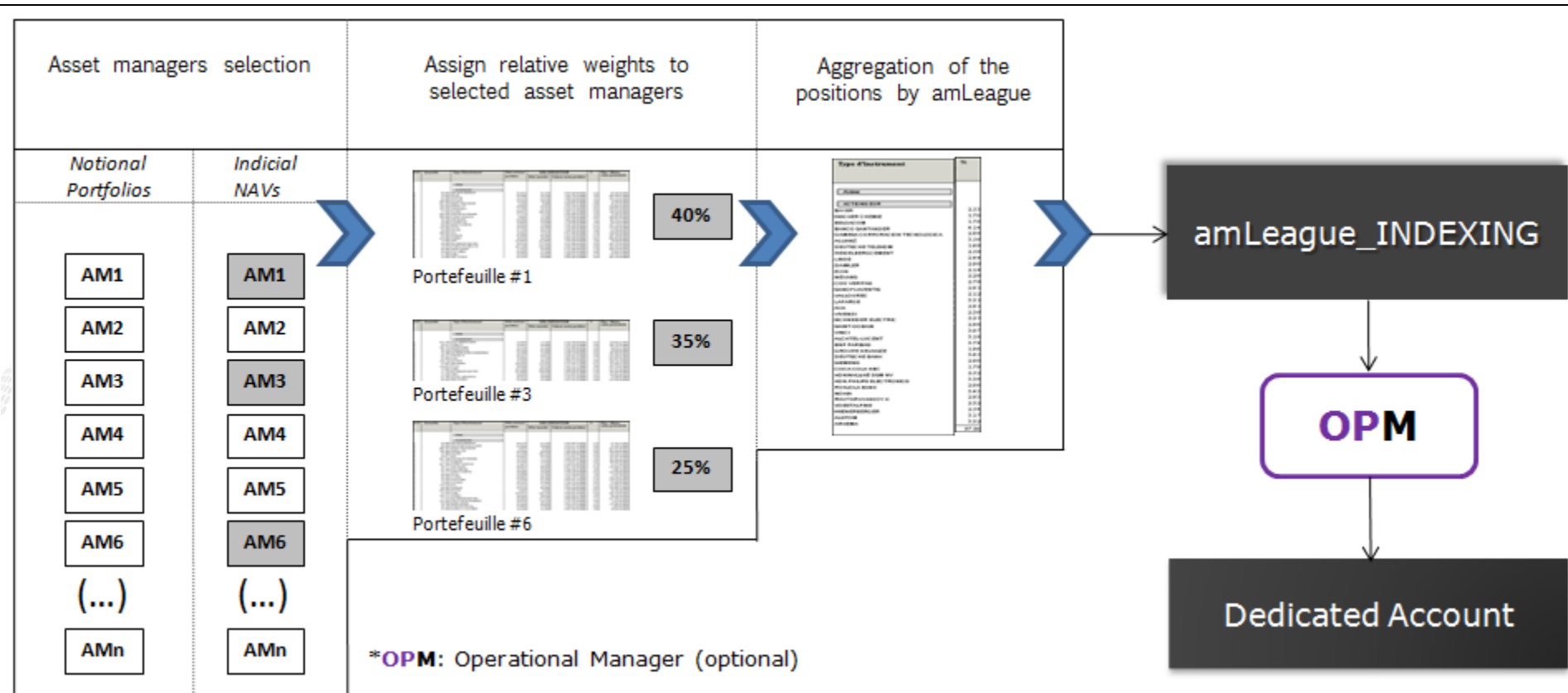


4 amLeague families of indices:

- ★ Through the Strategy Computation Tool available on amLeague website, a multitude of strategies are available to investors, choosing the quantitative factors (performance, volatility, alpha, beta, etc.) that best suits them
- ★ Investors can then combine these factors in an optimal manner to create a fully customised strategy
- ★ amLeague creates upon demand a Customised Index corresponding to the customised strategy
- ★ The Index calculation is automated, fully transparent and replicable

Testing your own strategies in a simple and easy way

Parties involved in the creation and replication of an index

- ★ The Index Sponsor (amLeague or a third party) is responsible for
 - Selecting underlying asset managers composition (quantitative criteria)
 - Defining the criteria for strategy reshuffling (quantitative criteria)

- ★ The Index Administrator (amLeague) is responsible for
 - Warranting IOSCO/ESMA compliance
 - Calculating index composition and valuation
 - Adequate communication to the Operators

- ★ The Operators (a third party) is responsible for
 - Creating the replication vehicle in accordance with local authorities, ie. legal set up and reporting,
 - Executing necessary trades in order to replicate the index

 - Index characteristics
 - Calculation Guide
 - Changes in a method

 - Risks and conflicts of interests
- ★ Index Specification Guide, both for public and customised indices

 - Review and approve the cessation of an index
 - Review and approve the index reshuffling and/or rebalancing
